Releasor for himself or herself and on behalf of the minor agrees to indemnify Releasee and each of them from any loss, liability, damage or cost they may incur due to the presence of the minor on, in or upon the property or premises of Lincoln Trail Riders, Inc., whether caused by the negligence of the Releasee or otherwise.

Releasor for himself or herself and on behalf of the minor further releases Releasee from any claim whatsoever on account of first aid treatment or services rendered to the minor during his or her participation in horseback riding and/or horse shows.

Releasor hereby acknowledges and agrees that this release shall be ongoing and shall be in full force and affect each and every time Releasor engages in horseback riding and/or horse shows conducted by the Lincoln Trail Riders, Inc., or engaged in or upon their properties or with their horses or equipment and this release shall have the same affect as if were signed and executed upon each and every such date.

Releasor for himself or herself on behalf of the minor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Illinois and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding continue in full force and legal affect.
